Pool Master, Inc. agrees to provide quality pool-cleaning service in accordance with the terms set forth above. The initial term of this agreement will be three months, beginning the first day of the month following the commencement date above, and shall continue on a month-to-month basis thereafter. Termination of this agreement, by the undersigned, or by Pool Master, Inc. for non-payment prior to the initial term of this agreement, will cause the remainder of the initial term to be due and payable, as agreed reasonable liquidated damages.

After the initial term, only two business days' notice is required to guarantee timely cancellation, or to change the frequency or chemical plan chosen above. Changes to frequency and chemical plans do not affect the remaining terms of this agreement. Any rate changes initiated by Pool Master, Inc. will be preceded by 30 days written notice.

The initial and final months of this agreement are subject to pro-ration. **Otherwise, there are no pro-rations for extra weeks that occur from time to time during the year.** However, customer understands that during the week beginning December 25th and ending December 31st, no service will be performed in order to provide the Route Reps a paid vacation. **Thank you for this courtesy.**

We care about your pool. In order for Pool Master, Inc. to provide excellent service, customer understands and agrees:

1. To accept service and to provide independent access to the pool and all pool equipment, including timers, to Pool Master, Inc. Route Reps and their supervisors.
2. To maintain adequate water level in the pool to allow for proper circulation and maintenance.
3. To keep pool equipment in operating condition.
4. To notify Pool Master, Inc. of dissatisfactions in quality of service or missed cleans within 24 hours of their occurrence and to accept our timely remedy of the problem.
5. To pay all invoices in accordance with the terms stated herein. Late fees of \$25.00 per month shall be assessed on all past due balances. In the event that a collection process is initiated by Pool Master, Inc. to collect past due balances, it is agreed, that any and all collection and/or legal expenses, including but not limited to attorney fees and costs, shall be paid by the undersigned. All accounts are deemed made and payable in Phoenix, Arizona.
6. Non-payment of invoices and/or late fees is a material breach of this agreement and may result in immediate termination of service.
7. This is the entire agreement of the parties hereto. This agreement may only be modified in writing executed by both parties.
